Synopsis:

Amendments to the SOP Act: Making Sense of the Key Changes

Amendments to the Building and Construction Industry Security of Payment Act (“**SOP Act**”) will come into force later this year. Many of the amendments are intended to address shortcomings and ambiguities in the SOP Act that became evident in cases before the Courts and adjudicators. These amendments will impact the preparation of construction and supply contracts, the administration of progress payments and the conduct of the adjudication process.

To help make sense of the key changes to the SOP Act, this session will cover the following:
